Pastor's Report

After three years, Prospect is emerging from COVID-19 a little older, a little smaller, and grateful to be able to worship together in person and on Zoom. This has been a year of coming back together and welcoming some new people into our midst, including young children, retirees, and our every-growing Germany contingent. We are getting small enough that populating all our boards and teams is a concern, so we are proposing some changes to lighten the load, but these will add to our budget. The Church Board, Trustees, Worship and Music Team, Social and Environmental Justice Team, Vitality Team, and others have all pitched in.

Here are just some of the ways I am grateful for this congregation this year:

- We continued to step up to meet the needs of our Afghan refugee family, the Hamidis. They are now established, and our efforts with them have wound down.
- We expected to run a deficit but never did. Thank you!
- When my sabbatical a year ago ended up staying local because of the pandemic, the leftover funds were approved for my pilgrimage to the Isle of Iona in Scotland in August. I was glad to share highlights of that experience in a worship service after my return and continue to be fed by that trip.
- This was a rough year personally when my mother had a stroke on October 1 and died a week later. Thank you for your support through that difficult time and beyond.
- We welcomed three new members on Easter Sunday!
- Music recitals have proved to be a popular use of our sanctuary on a pay-what-you-can basis.

Since November, I have been holding office hours at Macrina Bakery, a block away. Every Tuesday, I set out my "The pastor is in" sign and see who shows up. Sometimes no one comes, but usually between one and four Prospect folks join me, and we have lively discussions. The sign often attracts surreptitious glances from other customers and sometimes leads to wonderful conversations. A number of Prospect men also meet at Macrina on a near-daily basis. Macrina is becoming our community gathering space.

Karen Eisenbrey, our office manager for the past 13 years, retires at the end of this month. As much as we are sad to see her go, we wish her well on all the adventures to come. And we are grateful that she overlaps with the new office manager, Chase McAdams. Welcome, Chase!

We may be older and smaller, but we continue to step up. Rev. Traci Blackmon, the UCC's Associate General Minister and Vice President, Justice and Local Church Ministries, says it's not how many people gather but how many scatter to spread the Good News. May we continue to do both for many years.

Moderator's Report

My three years as Prospect moderator are coming to a close. Here are some highlights from my perspective of what has happened at Prospect in the past year:

We are continuing to keep the pastor position at 3/4 time (up from 1/2 time where she has been until January 2022).

The benefits have been:

improved communication between Meighan and the Church Board;

more time for her to do vitality work;

more time for outreach to the community;

and honoring and supporting the pastor position and Meighan in that role.

Our co-sponsorship with UCUCC of the Hamidis, an Afghan refugee family, officially ended in February. Several of us, under the leadership of Suzanne Anderson, finished up doing one on one tutoring last summer. With money from our "Afghan Refugee Fund" (which was started with a Weter-Roberts grant and that many of you donated to), we paid for sewing machine repair, fabric, driving lessons for Maliha (the mom), various household supplies, a TV set, cell phone for Mohammed (the dad), and gas reimbursement for tutors. The family of 8 are settled in their apartment in Skyway. Mohammed is driving for a car rental company. Maliha works part time at David's Bridal Shop in Tukwila doing alterations. Mustafa, the oldest son, is working toward a GED through Seattle Central College and working at a bakery. Omid, the second eldest, is in a similar program in Bellevue and works part time at McDonalds. The four youngest children are enrolled in the Renton School District. I am keeping in touch with the family via ZOOM and occasionally visit. They are very grateful for all we have done for them and have expressed an interest in keeping in touch with us.

We found a replacement for our office manager, Karen Eisenbrey, who will retire this June. Chase McAdams will overlap with her a bit to be trained. We are adding a few hours per week to the position for Chase to take on more building care duties to relieve some of the burden on the Board of Trustees.

We hired Melissa McQueen to supplement our volunteer tech help during hybrid worship as we are committed to continuing to be inclusive to our members and friends who live far away or have health issues that make attendance in person difficult.

I am most excited this past year about the vitality work we have done. Meighan's ¾-time position made this more possible. It started with a congregational survey to see where our strengths and challenges are as a congregation. We read *Real Good Church* by Molly Baskette. We formed a Vitality Team that met with Courtney Stange-Tragear, our former conference

Minister for Church Vitality who recommended we listen to the neighborhood and see where the needs meet our own capacity to do ministry.

Our church survey revealed a need for more opportunities for fellowship, which had been difficult due to COVID-19. We tentatively re-started "coffee hour" after church last Fall but it was poorly attended and Judy Hooper, our "Hospitality Coordinator" had trouble getting enough volunteers. So it was stopped in January, but we've been trying to have an after worship gathering at least quarterly and encourage folks to visit in the pews after worship.

Meighan has been negotiating with "Projects for a Civil Society," a non-profit who may be moving their office into our building. They work to prevent incarceration of youth and the formerly incarcerated transitioning back into society. Their board is mostly BIPOC. So we may not only be getting a new tenant but a new mission opportunity to help us "walk the talk" of striving to be an anti-racist congregation.

Bob Bakke left 1/4 of his residual estate to Prospect Church. About \$100,000 of that was spent on building painting and a new roof. There is about \$150,000 left. The Church Board wants the remaining funds to be spent in a way that reflects our Church Purpose and Working Covenant and to improve the vitality of our church. Our neighborhood is full of families with young children and one new member has asked for our worship services to be more child friendly. We held a congregational listening meeting May 7 where we presented a proposal to create a new ½-time position of "Minister for Children and Families". This person would work with Meighan to create more family friendly worship experiences, reach out to the neighborhood for ways to attract families with young children and perhaps re-create a Sunday School program. The response to the proposal was unanimously positive so we will add it to our annual church budget that we present at the Annual Meeting.

I am grateful to the five new (Dave Kidder, Suzanne Fry, Amy Miller, and Ralph Cobb) and one returning (Patsy Severson) members who will serve on our Church Board this coming year, July 2023 through June 2024. As of this writing, no one has offered to be moderator so we will be trying a new leadership model, perhaps with rotation of duties involved with planning and running meetings.

I am also grateful for the opportunity to step away from a leadership role and to listen to what God has in store for me (and Prospect) next.

Board of Trustees

Jerry Sams remains a stalwart of the Trustees overseeing and problem-solving needs for building use, management of the facility, and technical support for Sunday Worship and Zoom development.

In addition to the many repairs needed for the building and landscape, the Trustees continue to oversee cost-saving measures to reduce the overall operating expenses and budget of Prospect.

Future upkeep:

In order of priority, the future upkeep of our building will include the negotiation to rectifying a defective roof installation and associated damage to the building, continued management of our elevator, ongoing improvements to electrical, audio system, and hybrid worship needs, restoration of shed and outdoor staircase.

Present projects:

The most pressing concern on the Trustees agenda is the defective roof that was installed on our building last summer and the water damage that resulted this past winter. Unfortunately, this will

take some time to play out with Reliable Roofing Company. We will not be able to address the damage to the building until an adequate roof is in place. We are hopeful that the roofing company that performed the installation will rectify the situation and that Reliable will cover the cost for the damage that was caused to the building. However, there is the possibility of legal recourse if Prospect is not provided with a reasonable response to the situation.

The Trustees firmly believe that our building is still a relevant asset. With continued maintenance and upgrades, the building will support Prospect's pursuit of ministry.

Gratitude and Generosity Team

The Gratitude and Generosity Team has met monthly this past year. We arranged for regular Gratitude and Generosity speakers in worship and provided monthly newsletter articles. We continue to plan to meet year-round with the objectives of affirming gifts of members, looking for ways to express gratitude for one another and encouraging generosity of finances and service to Prospect. The members are Judy Hooper, Stacy Chilberg, Rick Russell, Cora Trujillo (as moderator), and Pastor Meighan. The 2023-24 pledge campaign resulted in 28 pledges totaling \$97,430.

Social and Environmental Justice Team

Rev. Courtney Stange-Tregear, who was our Conference Minister for Church Vitality and then our Interim Conference Minister, suggested that we listen to our community and find partners with whom to do ministry to meet community needs. Here are some ways in which we have been following that advice.

After a meeting with the principal and social worker at Stevens Elementary, we held a food drive and then a winter clothing drive for Tutu's Pantry, which serves students at Stevens who are experiencing food insecurity. We continue to look for ways in which to develop partnerships with Stevens.

The SEJ Book Group continues with gusto, reading books about climate change and antiracism and discussing them on Zoom.

The SEJ Team restarted the environmental justice film series in April in conjunction with Earth Day and hopes to show 3-4 films per year. The next film showing will be in August.

At the suggestion of a SEJ Team member, Pastor Meighan joined the Green Buildings Now Leadership Team and Outreach Committee over a year ago. Green Buildings Now is a small group of people of faith working to raise funds to help with the transition away from fossil fuels and toward climate resilience. This group has focused on helping Bethany UCC on Beacon Hill become a resilience hub for its low-income, multiracial community. Green Buildings Now was instrumental in obtaining City funding for most of the resiliency hub project at Bethany UCC, and that project is well underway. Green Buildings Now is currently in discernment regarding future projects.

In December, we invited one of our tenants, One Equal Heart, to speak in worship and set up tables of woven goods after worship in December. People could do some Christmas shopping and also support One Equal Heart's work with women of southern, rural Mexico.

We look forward to working with a new tenant, Project for a Civil Society. This organization works on conflict mediation, focusing in particular on the prison population. We hope to learn more from this organization about how to do this amazing ministry.

Weter-Roberts

The board met on May 2 to review 6 applications for grants received by the deadline of April 30. Board members Suzanne Fry, Robin Russell, Patsy Severson, and Cora Trujillo were present on Zoom. Jack Force, co-Chair, offered his thoughts earlier in the afternoon and gave his proxy to Suzanne as 2nd co-Chair.

Following the stipulations of the endowment we had \$4500 to disburse this year. The recipients and amounts are as follows:

- Community Lunch on Capitol Hill \$900 (5 meals each week for homeless and low income)
- Projects for a Civil Society \$900 (workshops in prisons, jails and recovery facilities)
- Camp N-Sid-Sen and Retreat Center \$800 (Outdoor Ministries)
- Be:Seattle \$700 (Tenants' rights and homeless assistance)
- One Equal Heart \$700 (work with indigenous peoples in Chiapas, Mexico)
- Amy Miller \$500 (school supplies for students in need)

Worship and Music Team
